## **ACCIDENT WAIVER AND RELEASE OF LIABILITY FORM**

Discharge, Waiver, and Release. THIS IS A RELEASE OF LIABILITY. BY PARTICIPATING IN ANY AND ALL ACTIVITIES ASSOCIATED WITH THE OSAGE STEER ROPING ASSOCIATION,

I AM AGREEING TO RELEASE THE OSAGE STEER ROPING CLUB (HEREBY KNOWN AS OSRC) AND OTHER PARTIES FROM LIABILITY. I HAVE THEREFORE BEEN ADVISED TO READ THIS DOCUMENT CAREFULLY.

I acknowledge that participation in the OSRA is an inherently dangerous activity. I further acknowledge that my participation in the OSRA exposes me to substantial and serious hazards and risks of property damage, personal injury and/or death. In consideration of my being permitted to participate in the OSRA, I hereby agree to assume such hazards and risks.

I further agree to discharge, waive, release and covenant not to sue the OSRA and all OSRA sponsors, all OSRA members (including, without limitation, contestants, Stock Contractors, rodeo Producers and Contract Personnel), and any other OSRA-sanctioned event production entity, and each party's respective officers, directors, employees and agents (collectively referred to as the "Released Parties"), from all claims, demands and liabilities for any and all property damage, personal injury and/or death arising from my participation in the OSRA. This Discharge, Waiver and Release includes all claims, demands, and liabilities, whether known or unknown, foreseen or unforeseen, future or contingent, and includes claims, demands and liabilities arising out of the negligence of the parties so release d. This Discharge, Waiver and Release also includes claims, demands, and liabilities for indemnities and contributions arising from property damage, personal injury and/or death to a third party.

I further agree to indemnify and save and hold harmless the Released Parties from any and all claims, demands, and liabilities for any and all property damage, personal injury and/or death asserted by a third party (defined as any party other than the Released Parties or me) and arising from my participation in the OSRA. In the event that any provision of this Discharge, Waiver, and Release is determined to be invalid for any reason, such invalidity shall not affect the validity of any other provisions, which other provisions shall remain in full force and effects as if this Discharge, Waiver, and Release had been executed with the invalid provision eliminated.
